

अतिरेकी अथवा देशविघातक कृत्य करणा-या व्यक्ती ह्या पुणे शहरातील कोणत्याही पोलीस स्टेशनच्या हद्दीत निवासी क्षेत्रात (फ्लॅट, रुम, बंगला) अथवा प्रार्थनास्थळ, धर्मशाळा, हॉटेल, लॉजेस या ठिकाणी भेट देऊन अथवा राहून पुणे शहरात अतिरेकी कारवाया करण्याची शक्यता आहे. त्या अनुषंगाने सदर ठिकाणांचा वापर करू देणारे मालक/भाडेकरू यांची तसेच जुनी वाहने खरेदी आणि विक्री करणा-या लोकांची माहिती पोलीसांना देणे बंधनकारक आहे. सदर माहिती न दिल्यास ती व्यक्ती भारतीय दंड विधान संहिता कलम १८८ प्रमाणे शिक्षेस पात्र राहिल याची सर्व संबंधितांनी नोंद घ्यावी.

तरी याबाबत आपले वृत्तपत्रातून प्रसिध्दी होणंसे विनंती आहे.

Order

Whereas there is always possibility of plan that terrorists, anti-national / anti-social elements may take up temporary and private employment and seek hide outs in the residential areas of the Pune city and there is every likelihood of breach of peace, and disturbance of public tranquility, and grave danger to human life and safety as well as damage to the public property in the areas of police stations under the control of Commissioner of Police, Pune City.

And whereas, it is necessary that some checks should be put on private employers , so that terrorist / anti-national / anti-social elements in the guise of the private employees may not cause disturbance of peace etc. and that immediate action is necessary for the prevention of the same.

Now therefore, I, **Ravindra Rasal** , Asst.Commissioner of Police, **Special Branch-1 Pune City** in exercise of powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973 (No. 2 of 1974) r/w Govt. notification No. MSC.1274/V-D dated 01 April 1974, do hereby order that no private employers falling under the jurisdiction / area of any Police Station controlled by the **Commissioner of Police, Pune City** shall provide employment to any person unless and until the person so employed has furnished his detail particulars such as , full name residential address , hometown address along with relevent documents. The employers shall get the antecedents of all the employees verified themselves and send report regarding the verification of the employee to the concerned Police Station.

The order shall come in force with effect from 21/05/2019 and shall be effective for a period of 60 days, i.e., upto 19/07/2019 (both days inclusive).

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

As the Notice cannot be served individually on all concerned, the order is hereby passed ex-parte. It shall be published for information of the public through press and by affixing the copies on the Notice Boards at the offices of Sr.P.Is., A.Cs.P., D.Cs.P and the copies shall also be furnished to all Cantonment Boards, PMC offices in Pune City Area and also be affixed at conspicuous places in the locality. The Police Officers will also promulgate this order as per the provisions of Sec.134(2) of the Criminal Procedure Code.

Order

Whereas there is always possibility of plan that terrorists, anti-national / anti-social elements may hide in the residential areas to carry out their plans in area of Pune city and there is every likelihood of breach of peace and disturbance of public tranquility, and grave danger to human life and safety as well as damage to the public property in the areas of police stations under the control of Commissioner of Police, Pune City.

And whereas, it is necessary that some checks should be put on landlords, tenants, custodians of private and public properties, trustees of Temples, Gurudwaras, Churches, Masjids, Dharmashalas, owners and purchasers / lessors of second hand (used cars) vehicles etc., so that terrorists / anti-national and anti-social elements in the guise of tenants or visitors or other residents may not cause disturbance of peace etc. and that immediate action is necessary for the prevention of the same.


Now therefore, I, **Ravindra Rasal**, Asst. Commissioner of Police, **Special Branch-1 Pune City** in exercise of powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973 (No. 2 of 1974) r/w Govt. notification No. MSC.1274/V-D dated 01 April 1974, do order that no landlord /owner/occupant of any house/property, custodians of private and public properties, trustees of Temples, Gurudwaras, Churches, Masjids, Dharmashalas, owners and purchasers / lessors of second hand (used cars) vehicles etc., falling under the jurisdiction / area of any Police Station controlled by the **Commissioner of Police, Pune City** shall let / sublet / rent out or sale or give for temporary use any accommodation or any such vehicle to any person, visitor or guest unless and until he has furnished the particulars of such tenant / tenants or purchaser or user of that property, viz flat, room, bungalow or such vehicle etc. to the concerned Police Station. All persons who intend to let out accommodation on rent or who intend to sale or use such accommodation or such vehicle shall inform in writing in this regard to the respective Police Station in whose jurisdiction the premises or such vehicle falls. The persons dealing in the property business, estate agents, agents dealing in such vehicles or by whatever name (s) they are called, shall also inform in writing to the officer-in-charge of the Police Station in whose jurisdiction the premises or such vehicle falls about the particulars of the said tenants or purchaser of such vehicle.

The order shall come in force with effect from 21/05/2019 and shall be effective for a period of 60 days, i.e., upto 19/07/2019 (both days inclusive).

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

As the Notice cannot be served individually on all concerned, the order is hereby passed ex-parte.
